Eligibility, requisites, procedure, terms & conditions etc.:

- (A) Candidates must be Citizen of India within meaning of Article 5 to 8 of the Constitution of India.
- (B) Candidates must not be of age less than 18 years and more than 43 years as on 1st January 2019. However the upper age limit is relaxable in case of SC, ST & other candidates as per Govt. OM No. ABP 06/2016/04. Dtd. 3st March. 2016.
- (C) Candidates applying for the above post must possess the prescribed minimum qualification mentioned above.
- (D) The period from the granting of the Driving Licenses should be a minimum of 5(five) years at the time of applying the posts.
- (E) Candidates, who are already employed, should submit their application through proper channel.
- (F) Candidates will have to appear for written test/driving test at their own expenses if and when called for.
- (G) The candidates qualifying in the written test shall be called for Driving skill test and original documents verification process. For every position, candidates shall be called for Driving skill test and original documents verification process in the ratio of 1:4 in order of merit as per the written test marks. The candidates will have to bring their original testimonials for verification alongwith a set of self-attached photo copies of testimonials and to be produced at the time of Driving skill test.
